AN ORDINANCE OF GREENWICH TOWNSHIP, BERKS COUNTY, PENNSYLVANIA, ADOPTING ROAD CUT STANDARDS AND SPECIFICATIONS; REQUIRING A PERMIT FOR ALL ROAD CUT IN THE TOWNSHIP; ADOPTING A SCHEDULE OF FEES FOR ROAD CUT PERMITS; PROVIDING FOR A SEVERABILITY CLAUSE; PROVIDING A REPEALER CLAUSE; AND PROVIDING FOR AN EFFECTIVE DATE

BE IT ENACTED AND ORDAINED, by the Board of Supervisors of Greenwich Township, Berks County, Pennsylvania, (the "Township") and it is hereby ENACTED AND ORDAINED by the authority of the same as follows:

SECTION 1. All road cuts in the Township must be performed in accordance with the "Road Cut Standards", as prepared by Technicon Enterprises, Inc. II, Project No. B-4006-ROP, consisting of Drawing 001 and 002, as more fully set forth in Exhibit "A", attached hereto and incorporated herein by reference, as amended from time to time, by Resolution.

SECTION 2. Permits. A Permit shall be required to perform any and all Road Cuts in the Township. Permit Applications for Road Cuts shall be obtained from the Township and no Road Cut shall be started until said Permit is received.

SECTION 3. Permit Fees. A fee for each Road Cut Permit shall be paid in accordance with the Township's Schedule of Fees, attached hereto as Exhibit "B" and incorporated herein by reference, as amended from time to time, by Resolution.

SECTION 4. Violation and Penalties. Any person, firm or corporation who or which shall fail to comply with any of the requirements hereof or a directive of the Code Official or other authorized person or of a permit or certificate issued under the provisions of this Ordinance shall be subject to the civil enforcement procedures, fines, and schedule of fines as set for the in Ordinance No. 1997-3, the "Civil/Criminal Enforcement Procedure Ordinance of Greenwich Township".

SECTION 5. If any sentence, clause, section, article or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, causes, sections articles or parts of this Ordinance. If is hereby declared as the intent of the Township Board of Supervisors that this Ordinance would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section, article or part thereof not been included herein.

SECTION 6. All ordinances or parts of ordinances of this Township which are inconsistent herewith are hereby repealed.
